# STEP 1 RATES

(effective through September 3, 2018)

# **APPLICABILITY**

Applicable within the entire territory served.

# **AVAILABILITY OF SERVICE**

Available for general domestic, commercial and industrial water service.

# **DELAYED PAYMENT PENALTY**

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

#### **RECONNECT FEE**

\$20.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

# PRIVATE FIRE INSURANCE SERVICE FEE

Annual private fire service fee of \$165.00 for all unmetered private fire service connection lines.

# **TAP FEE**

The following charges are to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$300.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

# LEAK ADJUSTMENT

\$6.61 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.

# RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the water utility up to a maximum of \$25.00 will be imposed upon any customer whose check for payments of charges is returned by a bank due to insufficient funds.

#### SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars, whichever is greater. This fee may change by applicable statutory provisions.
