

RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

**STEP 1**

**APPLICABILITY**

Applicable within entire territory served.

**AVAILABILITY OF SERVICE**

Available for general domestic, commercial and industrial service.

(I) **RATE** (Customers with metered water supply)

First	3,000 gallons used per month	\$10.80 per 1,000 gallons
Next	7,000 gallons used per month	\$10.59 per 1,000 gallons
Next	15,000 gallons used per month	\$10.12 per 1,000 gallons
Next	25,000 gallons used per month	\$ 9.56 per 1,000 gallons
All Over	50,000 gallons used per month	\$ 9.30 per 1,000 gallons

(I,C) **MINIMUM CHARGE**

No bill will be rendered for less than the following based on meter size:

5/8 x 3/4 inch meter	\$ 32.40 per month
3/4 inch meter	\$ 48.60 per month
1 inch meter	\$ 81.00 per month
1-1/2 inch meter	\$ 162.00 per month
2 inch meter	\$ 259.20 per month
3 inch meter	\$ 518.40 per month
4 inch meter	\$ 810.00 per month
6 inch meter	\$1,620.00 per month

**DELAYED PAYMENT PENALTY**

The above schedule is net. On all accounts not paid in full when due, ten percent will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

**STEP 1** (Continued)

**SECURITY DEPOSIT**

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

**TAP FEE**

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$300.00 will be charged to customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the service.

**RECONNECTION CHARGE** - \$20.00

To be charged whenever the supply of water is turned off for violation of rules, non-payment of bills or fraudulent use of water.

**ADMINISTRATIVE FEE** - \$20.00

To be charged whenever the utility dispatches personnel to turn off the supply of water for non-payment of bills and the customer makes payment prior to actual disconnection.

**RETURNED CHECK CHARGE**

A service charge equal to the actual bank fee assessed to the District up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

(D) **LEAK ADJUSTMENT RATE**

\$3.62 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such unusual consumption above the customer's historical average usage.

**STEP 1** (Continued)

**REQUESTED METER TEST**

A customer requesting that their meter be tested outside the normal testing period will be charged \$15.00. If the meter is found to be more than 2% in error, the amount shall be promptly refunded to the customer. If the meter is not found to be more than 2% in error, the District shall retain the amount advanced by the customer for the test. If the meter must be tested by another certified agency, other than the Summit Park PSD technician, the customer must pay the full costs incurred by the District involved in the testing. The District will provide the approximate amount to be deposited by the customer in advance of the testing.

(I) **PRIVATE FIRE PROTECTION SERVICE**

Where connections, hydrants, sprinklers, etc., on private property are maintained by customer and are not metered:

4 inch connection	\$ 7.28 per month
6 inch connection	\$24.23 per month
8 inch connection	\$48.49 per month
